b	Bidder should supply illustrated leaflet giving technical details of Goods/ Item and attach the same with the tender to facilitate evaluation.
c	No option(s) regarding price of Goods/ Items shall be entertained in the price bid. Bidder should quote the price of only one best & appropriate model of Good/Item available with them.
d	Purchase Preference will be given to “Make in India products” as defined in Purchase Preference with Local Content (PP-LC) Policy. Accordingly, bidders with Local Content less than or equal to 20% will be treated as “Non Local Supplier”. The prescribed LC shall be applicable on the date of Bid opening.
