	c	Bidder should quote the price of only one best & appropriate model of Goods/Item available with them.
	d	Purchase Preference will be given to “Make in India products” as defined in Purchase Preference with Local Content (PP-LC) Policy. Accordingly, bidders with Local Content less than or equal to 20% will be treated as “Non Local Supplier”. The prescribed LC shall be applicable on the date of Bid opening. The bidder shall submit an undertaking along with the bid stating the bidder meets the mandatory minimum LC requirement and such undertaking shall become a part of the contract.
