4. **Query:** Clarification regarding MSE Relaxation for Turnover and Experience Dear Sir/Ma'am, With reference to Clause No. 10 of the additional terms and conditions and the GeM Bid Document details, we would like to bring to your kind notice that as per the GeM Bid specifications, MSE Relaxation for Years of Experience and Turnover is explicitly allowed as follows: MSE Turnover Value: ₹1000 Lakhs (₹10 Crore) as Minimum Average Annual Turnover. MSE Past Experience: 2 Years. However, Clause No. 10 of the document mentions a strict requirement of ₹30 Crore turnover in each of the three financial years specifically from housekeeping services. As a registered MSE bidder, we request you to kindly clarify and confirm that: The relaxed turnover criteria of ₹10 Crore (Average Annual Turnover) will be applicable to MSE bidders instead of ₹30 Crore in each year. The relaxed experience criteria of 2 years will be applicable to MSE bidders instead of 7 years. Kindly confirm if our understanding is correct and if a CA certificate showing an average turnover of ₹10 Crore or above will be fully accepted for MSE participants.

As per the tender conditions, MSEs are eligible only for the partial relaxation specified in the bid document and not for complete exemption from the eligibility criteria. No relaxation beyond those expressly provided in the bid document shall be allowed to any bidder. The relaxed criteria are as follows:
