Eligibility Criteria

1. Only for 2025 Admitted Students **B.Tech/ Dual Degree** (B.Arch/B.Plan not Eligible) having CGPA ≥ 8.50 (Gen/OBC/EWS category) and CGPA ≥ 8.00 (SC /ST & PwD category) and must have cleared all subjects.
2. Candidates should have no F and /or I grade

Important Instructions

1. All interested applicants are required to fill prescribed format (format attached at Annexure)
2. All interested applicants are required to be present on **24/07/2026 at 10 AM in Hall no.1 of New Lecture Hall Building (in front of Civil Engineering Dept.)** along with all original documents with self attested photocopies of 12th Class, 1st & 2nd semester marksheets (if marksheets not available than required copy of online result) and category certificate **with filled format dully signed by student** and guardian for participation in internal sliding process. Any student absent or late i.e. after **10:30 AM** shall not be considered for up-gradation.
3. The strength of discipline from which transfer is being made does not fall below 90% of the existing strength.
4. Interested students should apply in prescribed form (available on website).
5. Students are advised to consult their parents for change of branch. Branch once allotted will be final & binding to the student. Student may also exercise option of branches where vacancies are indicated as NIL. Subsequently created vacancies in respective departments will be refilled as per students options.
6. The allotment will be made on merit as per CGPA of the student and the option given by him.
7. Merit list will be prepared according to their CGPA in first year. In case of tied CGPA score their JEE(Main-2025) All India Rank (through which they have taken the admission in first year) will be used.
8. Students admitted in B.Tech. will be allowed to change his branch in B.Tech. courses only.
9. The reservations of SC, ST.OBC, PwD etc will be kept as it is and no change of category will be permitted as per MoE guide lines.
10. The home state quota and other state quota will be kept as it is as per MoE guide lines. The option of interchange in quota will not be entertained. It means the vacant seat of Home State Quota will be offered to the candidate of Home State quota only and seat of Other State Quota will be offered to the candidate of Other State Quota.
11. The seats which will remain vacant after the process of branch change, will be kept vacant if the student of relevant quota is unavailable.
12. The students admitted through DASA or GOI nomination are not permitted to take part in this process.
