Instructions for the candidates who have submitted their application

All candidates who have applied in the Rolling Advt. No. Rectt/FR/2024/2262 and Advt. No. Rectt/FR/2024/2263 dated 30.01.2024 for the above-mentioned departments may go through the following instructions for compliance:

(1) Candidature of candidates shown as Provisionally Eligible is purely based on preliminary scrutiny of information provided by them. It creates no right in favour of any candidate and Institute reserves the right to debar a candidate for further stages of recruitment if information provided is found to be false/ incomplete. Merely appearing in the list of Provisionally Eligible candidates does not guarantee that a candidate shall be called further in the recruitment process.

(2) Candidates who have been marked Provisionally Ineligible (Not Eligible), if they like, may prefer a representation to the Institute, if they feel that reason mentioned for non-eligibility does not reflect the true position. Such representation, bearing title of the subject as **“Representation against Application No for the post of under the department of”**, citing cogent reasons along with supporting documents, may be submitted only through Email to faculty.recruitment@manit.ac.in on or before **08/08/2024**, failing which their candidature shall be liable to be cancelled without any further notice. No vexatious representations shall be considered and no query on result of consideration of such representation shall be entertained.

(3) Applications received after 31/03/2024 would not be considered in the current cycle and they shall be considered in the upcoming recruitment cycle of MANIT Bhopal.

(4) Candidates who were found Provisionally Eligible due to deficiency in application/documentation have to submit (only by email to faculty.recruitment@manit.ac.in) required documents/certificates bearing title of the subject as **“Representation against Application No for the post of under the department of”**, on or before **08/08/2024**, failing which their candidature shall be liable to be cancelled without any further notice.

(5) **Mere submission of objection will not confer any right/claim in favor of his/her candidature for being eligible.** The utmost attention shall be paid to the justification provided by the candidate; however the decision of the institute shall be final and binding to the candidate.

(6) E-mails received after the prescribed date would not be entertained. No individual communication is being sent to candidates, and Institute shall not be responsible to candidates who could not take appropriate action due to their failure to visit the website within stipulated time.

(7) The details concerning Provisionally Eligible, Provisionally Ineligible (Not Eligible) and further process etc. for other departments shall be notified shortly on the institute website.

(8) Applicants are advised to regularly visit the institute website for further updates.
