## **NOTICE**

### **Instructions for the candidates who have submitted their application**

#### **Against Advt. No. Rectt/FR-2/2025/2068 dated: 15.10.2025**

All candidates who have applied against Advt. No. Rectt/FR-2/2025/2068 dated 15.10.2025 may go through the following instructions for compliance:

(1) Candidature of candidates shown as Provisionally Eligible is purely based on preliminary scrutiny of information provided by them. It creates no right in favour of any candidate and Institute reserves the right to debar a candidate for further stages of recruitment if information provided is found to be false/ incomplete. Merely appearing in the list of Provisionally Eligible candidates does not guarantee that a candidate shall be called further in the recruitment process.

(2) Candidates who have been marked Provisionally Ineligible (Not Eligible), may prefer a representation to the Institute, if they feel that reason mentioned for non-eligibility does not reflect the true position. Such representation, bearing title of the subject as "**Representation against Application No ..... for the post of ..... under the department/centre of .....**", citing cogent reasons along with supporting documents, may be submitted only through Email to [faculty.recruitment@manit.ac.in](mailto:faculty.recruitment@manit.ac.in) on or before **05/01/2026**, failing which their candidature shall be liable to be cancelled without any further notice. No vexatious representations shall be considered and no query on result of consideration of such representation shall be entertained.

(3) Hard copy of applications received after 27/11/2025 have not been considered.

(4) Candidates who are Provisionally Eligible with deficiency in application/documentation have to submit (only by email to [faculty.recruitment@manit.ac.in](mailto:faculty.recruitment@manit.ac.in)) required documents/certificates bearing title of the subject as "**Representation against Application No ..... for the post of ..... under the department/centre of .....**", on or before **05/01/2026**, failing which their candidature shall be liable to be cancelled without any further notice.

(5) This being an advertisement under special recruitment drive for backlog faculty positions, candidates are required to produce the latest Category /PWD certificate in prescribed format in original before the presentation. Failing which they may be rendered ineligible to appear for presentation and further recruitment process. **All such candidates who have applied under OBC-NCL Category must ensure that, as per clause 37 under general instructions and information mentioned in the aforesaid advertisement, their category certificate is issued in prescribed format on or after 01.04.2025.** Otherwise, their candidature shall not be considered.

(6) **Mere submission of objection will not confer any right/claim to a candidate in favor of his/her candidature for being eligible.** The utmost attention shall be paid to the justification provided by the candidate; however, the decision of the institute shall be final and binding to the candidate.

(7) E-mails received after the prescribed date would not be entertained. No individual communication is being sent to candidates, and Institute shall not be responsible to candidates who could not take appropriate action due to their failure to visit the website within stipulated time.

(8) Applicants are advised to regularly visit the institute website for further updates.

(9) Candidature of all candidates shall remain provisional till all documents mentioned by the candidates are verified with original documents.
