Subject: Inputs on Lok Sabha Starred Question Diary No. S8955 on “Cyber Awareness Camps”

(a) Whether the Government is providing any support to prevent online frauds, phishing attacks and financial scams affecting rural internet users including those in Bengaluru Rural Parliamentary Constituency:

While MANIT Bhopal does not directly operate in the Bengaluru Rural Parliamentary Constituency, the institute supports the Government of India’s broader mission to combat cyber fraud through awareness-building activities. As part of the **Cyber Jaagrookta Diwas (CJD)** initiative by MeitY, MANIT has been conducting cyber awareness programs that cover topics such as phishing, financial scams, and digital hygiene. Although **no targeted programs have yet been conducted specifically for rural users**, all workshops and sessions are **open to participants from rural areas**, and such participation is actively encouraged.

(b) Whether any cyber awareness camps or grievance redressal training has been conducted in partnership with the State police or the district administration:

Yes, MANIT Bhopal has conducted multiple cyber awareness initiatives. These include:

- A **Cyber Security Awareness Workshop** held on **4th October 2023** as part of Cyber Jaagrookta Diwas, focusing on fraud prevention and cyber hygiene.
- A **One-Week Faculty Updation Program** on **“Cyber Security Threats and Forensics”** in **February 2024** under **ISEA-III**, supported by MeitY, which included components on digital grievance redressal and threat handling.

These programs were **not specifically targeted at rural populations**, but were **open to a broad audience**, including participants from rural and semi-urban backgrounds. **No formal partnerships with the State police or district administration have been executed yet**, but the institute is **open to future collaborations** with such authorities to extend its reach.

Importantly, **MANIT Bhopal is planning to organize future awareness workshops directly in rural areas** of Madhya Pradesh in collaboration with local institutions and administrative units. This will help expand the impact of cyber literacy initiatives among vulnerable rural internet users.

(c) Whether the Government proposes to launch a localized public awareness campaign on cyber hygiene in regional languages:

While the proposal and implementation of such campaigns lie with the Government, MANIT Bhopal **strongly supports** the idea. The institute is equipped to prepare and disseminate cyber awareness materials in **Hindi and local languages**, ensuring inclusivity for non-English speaking users.
