Visiting Clinical Counsellor (02- one male and one female):

<u>Essential Qualification:</u> (1) MA/M.Sc. degree in Psychology with specialization in Clinical/Counseling Psychology from a recognized University or Institute.

(2) Registration in a rehabilitation Council of India (RCI).

<u>Desirable Qualification & Experience:</u>

- (1) Two years of experience in counseling students in higher academic Institute/University.
- (2) M.Phil/Ph.D in Psychology.

<u>Remuneration:</u> Rs. 1,200/- per visit of 2 hours and 2 to 4 visits in a week. The number of visits (online/offline) can be increased or decreased depending upon the performance of the candidate as well as requirement of the institute.

<u>Contract period:</u> initially to be appointed on contract for a period of eleven months. Further extension shall be based on Institute requirement and performance of the individual.
